- Left Mount
- 1 Right Mount
- M10 X 1.5 X 30MM Socket Head Cap Screw

Metric hex bits, ft-lbs (Nm) torque wrench, snap ring pilers, blue loctite



- STEP 1 Read and understand all steps in the instructions before starting the installation. Park the motorcycle on a hard, level surface and turn off the ignition. Let motorcycle cool.
- STEP 2 Refer to PIC 1. Remove existing mounting hardware and passenger floorboard from the passenger floorboard mount. Be careful not to lose the two (2) dedent balls and springs that are located between the floorboard and floorboard mount. Set hardware and floorboards aside, they will be
- STEP 3 Refer to PIC 3. Remove existing passenger floorboard mount from the motorcycle. Set it aside, it will NOT be reused.
- STEP 4 Refer to PIC 4. Located provided Passenger Board Mount and M10 X 1.5 X 30MM Socket Head Cap Screws. Apply a small amount of blue loctitie to each screw.

Note: Take note of the stampings made on the backside of each mount. LH = Left Hand (clutch side) RH = Right Hand (brake side)

STEP 5 Align the provided mount with the mounting hole on the motorcycle. Secure it in place using the provided screw.

> **TORQUE VALUE FOR MOUNTING SCREW:** 35 FT-LBS (47.5 Nm)

STEP 6

Refer to PIC 5. Locate the OEM dedent balls and springs that were removed in Step 2. Place a spring into each hole located on the mount and place a dedent ball onto each of the springs.

STEP 7

Refer to PIC 6. Locate the passenger floorboard and mounting hardware that was removed in Step 2. Align the floorboard with the mount, being careful not to knock the dedent balls out of place. Secure it in place with the mounting hardware. Flip the passenger floorboard up and down to test for proper functionality.

STEP 8


Repeat Steps 2 through 7 on the opposite side.
